## **School Nutrition Update**

Mr. Tom Houle, Director of School Nutrition, provided a presentation update on the School Nutrition Program, reviewing the updates to the services, food options, free and reduce program and new equipment in the buildings.

#### **Pupil Services Update**

Ms. Joan DeAngelis, Director of Pupil Personnel Services, provided a presentation update on Special Education, reviewing new programs, transition classes, enhanced afterschool program and a SEPAC update. Ms. DeAngelis also provided an update on Pupil Personnel Services, reviewing the 504 process, building administration liaison for all student issues, grants, Community Partnership parent education sessions and play groups, social emotional curriculum, restorative justice and professional development results and opportunities.

## **MCAS Results Review**

Ms. Martina Kenyon and Assistant Superintendent Maguire provided a presentation on the 2018 MCAS results, reviewing the district accountability data, next generation MCAS (grades 3 - 8) achievement levels, new levels are not comparable to the past legacy levels, our district vs. state achievement levels, achievement vs. growth data, subgroup achievement levels, 2019 MCAS dates and next steps. A grade level breakdown and year over comparison will be presented at a future meeting.
