With attention to how the number and size of the parts differ even though the two fractions themselves are the same size. |  | In-depth focus |

| CC.4.NF.4b Understand a multiple of $a / b$ as a multiple of $1 / b$, and use this understanding to multiply a fraction by a whole number. <br> For example, use a visual fraction model to express $3 \times(2 / 5)$ as $6 \times(1 / 5)$, recognizing this product as 6/5. | CC.4.NF.4c Solve word problems involving multiplication of a fraction by a whole number, e.g., by using visual fraction models and equations to represent the problem. <br> For example, if each person at a party will eat $3 / 8$ of a pound of roast beef, and there will be 5 people at the party, how many pounds of roast beef will be needed? Between what two whole numbers does your answer lie? |  | In-depth focus |
| Understand decimal notation for fractions, and compare decimal fractions. |  | Major cluster |
| CC.4.NF. 5 Express a fraction with denominator 10 as an equivalent fraction with denominator 100, and use this technique to add two fractions with respective denominators 10 and 100. <br> For example, express $3 / 10$ as $30 / 100$ and add $3 / 10+4 / 100=34 / 100$. (Footnote: Students who can generate equivalent fractions can develop strategies for adding fractions with unlike denominators in general. But addition and subtraction with unlike denominators in general is not a requirement at this grade.) |  |  |
| CC.4.NF. 6 Use decimal notation for fractions with denominators 10 or 100. For example, rewrite 0.62 as $62 / 100$; describe a length as 0.62 meters; locate 0.62 on a number line diagram. |  |  |

| Solve problems involving measurement and conversion of measurements from a larger unit to a smaller unit. |  | Supporting Cluster |
| NRSD.4.MD.1.1 Know relative sizes of measurement units within one system of units including km, m, cm, in, yards, feet and miles; Know relative sizes of measurement units within one system of units including $\mathrm{kg}, \mathrm{g}$; lb, oz.; Know relative sizes of measurement units within one system of units including l, ml, c, pt, qt, and gallon; Know relative sizes of measurement units within one system of units including hr, min, sec. For example: Know that 1 ft is 12 times as long as 1 in. |  |  |

Record measurement equivalents in a two-column table. <br> For example: Express the length of a 4 ft snake as 48 in . An angle that turns through 1/360 of a circle is called a "one- <br> degree angle," and can be used to measure angles. |  |  |
